Please read the following carefully and initial next to each line stating that you understand and agree to comply with **City of Blue Mound Animal Control Ordinance No. 2018-05 Keeping of Backyard Chickens**.

_____ I the undersigned understand that only (1) one permit for backyard chickens may be issued per property, tract or individual lot, and that this permit is non-transferable and shall be valid and effective until the permit holder (person applying for permit) no longer resides at the property, ceases to keep backyard chickens on the property, or is otherwise revoked.

_____ I also understand this permit may be revoked upon a finding by the City of Blue Mound after written notice of two documented violations of this ordinance within a (12) twelve month period.

_____ I understand that only backyard chickens are allowed on my property, tract or individual lot, Male chickens (Roosters) may not be kept as backyard chickens. I also understand that turkeys, ducks, geese, peacocks and other fowl species are strictly prohibited and may not be kept on my property.

_____ I understand that chickens must be kept in a secure pen, coop, or enclosed backyard at all times and may not run at large. If found at large I understand that I may be subject to a citation being issued for this violation.

_____ I have received a copy of the **Standards for Keeping Backyard Chickens**, and **Care of Backyard Chickens** from the City of Blue Mound, and that if found in violation of this Ordinance more than twice in a twelve (12) month period this permit will be revoked and all Backyard Chickens must be removed from the City limits of Blue Mound, and I will no longer be allowed to keep Backyard Chickens on my property, tract or individual lot.

I, hereby certify that the above information is true and correct. I have read and initialed this document and understand that this permit allows me to keep backyard chickens on my property, tract or individual lot with in the city limits of Saginaw and that if found in violation of this ordinance more than (2) times within a twelve (12) month period, my permit will be revoked
